### Aerated Wastewater Treatment System - Annual Service Contract

The duration of the Agreement is ongoing until such time that written notification of cancellation is made by the Owner. The service fee may be adjusted from time to time with the Owner given a minimum 30 days notice of any such change.

Coastal Wastewater Specialists or their agent, upon payment of \$           **GST FREE per year (4 x quarterly services)**           and the signature of the afore-mentioned person at the place indicated below, and upon acceptance of this application by a duly authorized employee of Coastal Wastewater Specialists, agrees, for the period indicated to the following:

- Quarterly field service inspections will be made by a fully qualified and experienced employee during the twelve month period covered. The following items\* will be checked or tested at each quarterly service:

TESTED	CHECKED
pH level of effluent	Efficiency of chlorinator
Free residual chlorine level	Chlorine tablets (does not include cost of refilling chlorine.)
Level of dissolved oxygen	Efficiency of blower pressure and cleaning of filter.
Temperature of effluent	Backwash EPU where applicable.
High water level alarms	Efficiency of sludge and skimmer return systems.
Low air alarms	Check irrigation pump is operational
Clarity of water	Condition of irrigation area
	Electrical compartment is in good condition.
	Condition of all hoses and irrigation sprays
<b>ANNUAL check and test only:</b>	Amount of sludge accumulation in the septic chamber. (De-sludging is NOT included.)

- Both labour and materials will be charged for any emergency service call outside the four calls specified above.
- This annual servicing agreement does NOT include the maintenance of the irrigation area or repairs to any part of the treatment system or the pumps. All repairs are on a strictly C.O.D. basis.
- This agreement does not bind Coastal Wastewater Specialists or it's duly appointed agent to be responsible for the quality of the effluent. However, it will at all times, wherever possible, recommend how the effluent quality can be maintained at its maximum and alter and adjust the system during these regular visits in an endeavour to obtain the best possible effluent standards.

In applying for this agreement, the undersigned acknowledges that this Agreement is binding while they are the owner/occupier of the premises. Coastal Wastewater Specialists will transfer the unexpired portion of this contract to any new owner/occupier to comply with the relevant health legislation.
